Personal data that we process

Ventiguard BV does not process personal data because no personal data can be left behind on our site. We also do not use social media plugins.

Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data about website visitors under the age of 16. Unless they have permission from their parents or guardian. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, to prevent data about children from being collected without parental consent. For what purpose and on what basis we process personal data

Ventiguard BV processes your personal data for the following purposes:

- To be able to call or e-mail you if necessary to carry out our services

Automated decision making

Ventiguard BV does not make decisions based on automated processing on matters that can have (significant) consequences for people.

How long do we keep personal data

Ventiguard BV does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. We use the following retention periods for all data: 10 years.

Sharing of personal data with third parties

Ventiguard BV only provides to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal commitment.

Cookies, or similar techniques, that we use

Ventiguard BV does not use cookies or similar techniques.

View, modify or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Ventiguard BV and you have the right to data portability. This means that you can submit a request to us for the personal data that we hold about you in a computer file to you or another organization specified by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to [info\(at\)ventiguard\(dot\)com](mailto:info(at)ventiguard(dot)com).

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black in this copy. This for protecting your privacy. We will respond to your request as soon as possible, but within four weeks. Ventiguard BV would also like to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
